## Work Health and Safety (WHS) Policy

## 1. Purpose

### 2. Scope

### 3. Responsibilities

## Management

- Ensure compliance with WHS legislation and Australian Standards.
- Provide leadership and resources to establish and maintain a safe working environment.
- Ensure that adequate training, equipment, and systems are in place for managing workplace health and safety.
- Review the effectiveness of safety programs and procedures regularly.

#### Supervisors

- Monitor daily operations and ensure work practices align with WHS requirements.
- Conduct regular risk assessments and implement control measures.
- Provide safety inductions and training to all new employees and contractors.

### **Employees and Contractors**

- Take reasonable care of their own health and safety and that of others in the workplace.
- Comply with all WHS policies, procedures, and instructions.
- Use appropriate PPE and safety equipment provided by the company.
- Report all hazards, injuries, or unsafe conditions immediately to their supervisor.

## 4. Risk Management

- Identify and assess risks to health and safety in the workplace.
- Implement control measures based on the hierarchy of controls:
  - 1. Eliminate the hazard wherever possible.
  - 2. Substitute with safer alternatives where elimination is not possible.
  - 3. Implement engineering controls (e.g., machinery safety guards, ventilation systems).
  - 4. Use administrative controls (e.g., work procedures, job rotation).
  - 5. Provide PPE where necessary (e.g., gloves, safety footwear, goggles).
- Review and monitor risk controls regularly to ensure they remain effective.

#### 5. Safe Work Procedures

- Develop and implement safe work procedures for all high-risk tasks and activities.
- Ensure that appropriate signage and instructions are visible to workers in hazardous areas.
- Provide clear communication channels for reporting safety concerns and hazards.
- Investigate all incidents, including near-misses, to determine root causes and prevent reoccurrence.

#### 6. Consultation and Communication

- Engage with employees and contractors in the development and review of WHS policies and procedures.
- Hold regular safety meetings to communicate health and safety issues, share updates, and discuss improvements.
- Ensure all workers have access to health and safety information and are informed about hazards in the workplace.
- Maintain open channels for feedback and suggestions from employees and contractors on safety improvements.

## 7. Training and Competency

- Provide WHS induction training to all new employees and contractors.
- Ensure all workers are trained and competent to perform tasks safely.
- Offer refresher courses and further training opportunities to maintain compliance with the latest safety standards.
- Maintain records of all training, certifications, and competency assessments for workers.

## 8. Emergency Response and First Aid

- Develop and communicate emergency response plans for various potential emergencies (e.g., fire, medical emergencies, chemical spills).
- Ensure first aid kits are available and stocked, and that personnel are trained in basic first aid.
- Provide access to emergency exits, fire extinguishers, and assembly points.
- Conduct emergency drills regularly to ensure preparedness in case of an actual emergency.
